



Call for participants and trainers

WHAT:

"YES (Youth Energizing Societies) - from simulation to action" is a training activity on prevention of human trafficking gathering 40 young people and youth workers from 5 partner countries from South East Europe and the EU who are active in their communities aiming to provide them with competencies in order to encourage dialogue and mutual understanding according to the ideas of solidarity and respect for human rights through non formal education and raising awareness of prevention of human trafficking in European context. This 6-day camp combines various learning methods such as case studies, panel discussions, trainings and workshops and exchange of practice.
