CONTEXT

Throughout our educational path we have identified that information, knowledge and action on/through Human Rights is threatened in a dangerous political context in Europe and in the world, with demonstrations of intolerance and violence/hatred spread in a climate of fear. Furthermore, despite Human Rights being on the political agenda for more than 70 years, there is still a wide gap between the promotion and the actual lives of people throughout the world, that still see their rights curtailed based in a myriad of discriminations – geography, gender, age, socio-economic factors, and so on. Human Rights will only be truly effective if everyone knows them and has the tools to fight for them. Therefore, education is the most powerful tool for transformation. It is necessary to create educational programs that aim to inform, build capacities and motivate educators in our organizations, in a process that ensures a structured dissemination and with pedagogical, multiplying and transforming effects.

Human Rights Education (HRE) is a participatory practice with the aim of mobilizing people and communities and empower them with knowledge, attitudes, values and aptitudes that are needed to enjoy and put in practice those rights and to respect and defend others' rights. HRE aims to build a world where everyone knows their rights and know how to fight for them.





This training is built upon a learning process that will lead the participants to act, either individually or collectively in their communities and globally. Beyond learning about Human Rights, the participants will also develop skills for action and competences for facilitation and training. It will bring participants from Portugal, Greece, United Kingdom, Sweden, Hungary, Netherlands, Spain, Czech Republic and Poland to share about their experiences and to build together a network of educators and trainers within their local contexts.

REDE INDUCAR

Rede Inducar is a NGO that promotes non formal education and social inclusion, taking action in different contexts, especially through networks and partnerships towards a more inclusive society, based on the empowerment of each person and a culture of responsibility and mutual learning.

GOALS





This training aims to create Pools of Trainers and Educators in the partner organizations in order to have a more active, continuous and transforming role in their local and regional realities.

This project aims:

- To train a group of educators, assuring the access to information, tools and methodologies of non-formal education that enables a better planning, implementation and evaluation of actions of education for human rights;
- To promote dynamism and critical thought of each organization to ensure a more effective role of advocacy for human rights through their existing and future projects;
- To put in practice the knowledge and experience of the organizations to train new educators, renovating organizations' activism and mobilizing spirit, contributing simultaneously for an increase in the quality of the management of human rights education projects and a more effective recognition and validation of competences in the realm of non-formal education:
- To develop a more continuous, up to date and intensified work of human rights education, through new pool of trainers created within each organization to achieve a broader impact and local transformation.

PROGRAM AND METHOLODOGY

In Human Rights in Action! these three dimensions will be explored, through different strategies and methodological approaches:

"ME AS PERSON"

from questions as: what do I know about Human Rights, how to build a Human RIghts culture?

"ME AS FACILITATOR OF LEARNING PROCESSES"

The training will be developed based on pedagogical/methodological principles of Non-Formal Education, which aim to stimulate the participants' creative potential and a critical and reflexive attitude towards their personal and professional experiences.






A broad set of methods and tools will be used – from the presentation of theoretical concepts to simulations and role-plays, individual and group work – ensuring that different profiles and learning styles are catered for.

PARTICIPANTS PROFILE

This training is aimed for people involved or with interest in being involved in Human Rights Education in Europe, specifically in Portugal, Greece, United Kingdom, Sweden, Hungary, Netherlands, Spain, Czech Republic and Poland. We aim to create a diverse group, with different profiles and experiences, as with different perspectives learning process will be richer and more productive. We are looking for participants with the following profiles:



SELECTION PROCESS

There will be 27 participants, 3 from each country - Portugal, Greece, United Kingdom, Sweden, Hungary, Netherlands, Spain, Czech Republic and Poland.





After the application deadline the participants selection will take into consideration the following criteria:

- Availability to attend the whole course, from the 26th September to the 4th October 2021;
- Motivation to take part;
- Interest and motivation to act as a trainer rand multiplier of Human Rights Education;
- Availability to integrate Pools of Trainers in the sending organizations;
- Diversity of profiles and experiences
- Gender balance in the group

The selection will be made based on the information provided in the application form.

LOGISTICS

The participation is free and the costs of accommodation and food are fully covered.
