C. Ba	ACKGROUND AND EXPERIENCE		
Please briefly present the partner organisation.	Udruga studenata političkih znanosti Hrvatska (USPZ Hrvatska) is a national association founded in 2018 that brings together students and graduates of political and related sciences from Croatia. The organisation has 18 active members and a contact list of 780 previous participants who receive project information. They have access to faculty spaces and equipment for project activities when needed. The association regularly inflows funds based on the projects it carries out, regularly meets its obligations, and increases the scope of its activities each year.		
What are the activities and experiences of the organisation?	<ul> <li>USPZ Hrvatska has conducted dozens of activities and projects in education, social inclusion, youth work, and STEM-related areas. Key projects and activities include:</li> <li>1. Simulated student sessions of the Croatian Parliament: Over 390 students have participated, discussing significant topics such as the introduction of property taxes, referendum law, and the law on control of opiates and psychedelic compounds.</li> <li>2. Institutional visits to the Croatian National Bank (HNB): Through these visits, more than 120 students have been introduced to the work and role of HNB, discussing topics such as the introduction of the euro and its effects,</li> </ul>		

- prevention of money laundering and terrorist financing, financial security, and the role of monetary policy in development.
- 3. "Towards the Euro" project (2022): Co-financed by the Student Center in Zagreb and the University of Zagreb Assembly.
- 4. "Included Youth" project: Implemented in multiple cities (Daruvar, Zagreb, Bjelovar) and municipalities (Dubrava, Sunja), connecting local and global issues.
- 5. Panel discussion on "Global Challenges and New Partnerships" (2022): Featuring professors from the Faculty of Political Sciences, the Ambassador of the State of Israel, and a representative from the Ministry of Foreign and European Affairs.
- 6. "Prevention of online addiction and promotion of financial literacy in the digital sphere" project (2023): Supported by SDUDM, implemented in 20 locations in Zagreb and four other regions.
- 7. Erasmus+ participation: Members have participated in 20+ youth exchanges and trainings.
- 8. "Information on EU Parliament Elections" project (2024): Funded by the Ministry of Foreign and European Affairs and the Student Assembly of the University of Zagreb, aimed at informing young people and students about European parliamentary elections and the importance of voting.
- 9. "Youth Program for Dubrava Municipality" (2024-2025): Funded by the Agency for Mobility and EU Programs, Erasmus+ program. Goals include empowering youth for active community participation, creating space for dialogue between youth and decision-makers, involving youth in developing and adopting the Youth Program, adopting innovative practices related to digital transformation and green transition, and developing and implementing the Youth Program for Dubrava Municipality for the next four-year period.
- 10. "Included in Euro" project (2022): Funded by the Student Center of the University of Zagreb, focused on familiarizing and educating students about the new currency the euro, which replaced the Croatian kuna.
- 11. "Online Addiction Prevention" project (2024): Funded by the Student Center of the University of Zagreb.
- 12. Cycle of prevention lectures for young people on the dangers and harmfulness of online betting and gambling, conducted by Pavao Škoko Gavranović and Filip Obradović.

What are the skills and expertise of key staff/persons involved in this application?

- (1) **Pavao Škoko Gavranović**: President, holds a Master's degree in Political Science with long-standing experience in civil society as a volunteer, employee, and in management positions.
