Establishment - Headquarters Chapter I.

For a non-profit purpose, an association called "MamAfrika Organization" was established, in accordance with Royal Decree No. 1.58.376 of 1958 and its amended laws. Under the motto: "Youth and Intergenerational Solidarity"

MamAfrika's social headquarters are currently located at Maison des jeunes al Qods, Rue 2, Lotissement Al Qods C, Casablanca, Morocco. This location serves as the organization's primary base of operations and community center. However, the board of association has the authority to relocate the headquarters to another location as deemed necessary.

Principles - objectives: Chapter II.

MamAfrika operates as an independent entity, with autonomy in its decision-making processes. The organization is politically and religiously neutral, prioritizing humanitarian efforts and non-partisan objectives. This autonomy enables MamAfrika to focus on its primary mission of assisting marginalized groups without bias or external influence.

MamAfrika is founded on the principles of volunteerism and cultural, social, humanitarian, and material heritage, as well as charitable and educational initiatives, with the aim of addressing the needs of marginalized communities worldwide. MamAfrika seeks to facilitate meaningful cultural exchange and strengthen global harmony, with a special emphasis on South-South relations.

Membership: Chapter III.

MamAfrika members are required to actively uphold the organization's principles and adhere to its policies and decisions.

Membership in MamAfrika may be revoked due to death, resignation, dismissal for non-compliance with organizational principles, regulations, or decisions, or failure to fulfill membership obligations.

Organs: Chapter IV.

The organs of the Assembly are composed of the General Assembly and the Governing Bureau.

The General Assembly is the highest decision-making authority and is composed of the Preparatory Committee, the General Committee of the Assembly, and the active members.

The General Assembly is held every seven years and in special sessions upon the invitation of two-thirds of the General Bureau of the Assembly or the President. The General Assembly aims to define and determine the General Assembly's strategic directions, priorities of work, amend laws, elect the General Bureau of the General Assembly, approve finances and reports.

The running Office of the Association is the executive organ of the Association and consists of 3 to 7 members, including the President (e) - Vice President - Treasurer - Coordinator in charge of cultural affairs - Coordinators of media and documentation and also ensures the normal and good functioning according to the decisions of the general assembly.


Finance: Chapter V.
