### **Description:**

The Emergency Response and Rescue Corps (E.R.R.C.) is a voluntary, charitable and not for profit organization based in Gozo, Malta. Is was created with the aim of preventing and alleviating human suffering, improving the situation of the most vulnerable people with absolute impartiality and without any discrimination as to gender, nationality, religion, race, class, religious or political beliefs. Its purpose is to protect and preserve human life and to ensure respect for the human being. Providing assistance to government established departments (as per statute) and entities is one of the functions that the organization performs. Furthermore, E.R.R.C. offers water rescue service at popular beaches around Gozo and Comino during the summer months, ambulance services and first aid posts during public events. E.R.R.C. has also a youth section know as the CADETS. E.R.R.C. is a volunteer-led humanitarian organisation that helps people in crisis, whoever and wherever they are. We are part of a global network of volunteers – the Samaritan International – responding to natural disasters, conflicts and individual emergencies. There are Almost three million members, 130,000 volunteers and 30,000 full-time employees form the basis of SAMARITAN INTERNATIONAL and the network in the different organizations and countries.

The vision of the E.R.R.C. is to be an effective, high profile, and dynamic humanitarian organisation, that is sensitive to the human needs of the most vulnerable communities.

- provide rescue services eg: lifeguarding Comino and Ramla, for 3 months 8 hours a day


